

PROPOSED  
SENATE AMENDMENTS TO H.C.R. 2037  
(Reference to House engrossed resolution)

1 Strike everything after the resolving clause and insert:

2 "1. Article IV, part 2, section 2, Constitution of Arizona, is  
3 proposed to be amended as follows if approved by the voters and on  
4 proclamation of the Governor:

5 2. Qualifications of members of legislature

6 Section 2. No person shall be a member of the  
7 Legislature unless ~~he shall be~~ THE PERSON IS a citizen of the  
8 United States at the time of his election, ~~nor unless he shall~~  
9 ~~be~~ IS at least twenty-five years of age, ~~and shall have~~ HAS  
10 been a resident of Arizona at least three years and of the  
11 county from which he is elected at least one year before his  
12 election AND HAS NOT BEEN A LOBBYIST WHO IS REQUIRED TO  
13 REGISTER WITH A FEDERAL AGENCY, THIS STATE OR A POLITICAL  
14 SUBDIVISION OF THIS STATE FOR TWO YEARS IMMEDIATELY PRECEDING  
15 THE PRIMARY ELECTION FOR THE LEGISLATURE.

16 2. Article V, section 2, Constitution of Arizona, is proposed to be  
17 amended as follows if approved by the voters and on proclamation of the  
18 Governor:

19 2. Eligibility to state offices

20 Section 2. No person shall be eligible to any of the  
21 offices mentioned in section 1 of this article except a person  
22 ~~of the age of~~ WHO IS not less than twenty-five years OF AGE,  
23 who ~~shall have~~ HAS been for ten years next preceding his  
24 election a citizen of the United States, and for five years  
25 next preceding his election a citizen of Arizona AND WHO FOR  
26 TWO YEARS NEXT PRECEDING HIS PRIMARY ELECTION HAS NOT BEEN A  
27 LOBBYIST WHO IS REQUIRED TO REGISTER WITH A FEDERAL AGENCY,  
28 THIS STATE OR A POLITICAL SUBDIVISION OF THIS STATE.

29 3. Article XI, section 2, Constitution of Arizona, is proposed to be  
30 amended as follows if approved by the voters and on proclamation of the  
31 Governor:

32 2. Conduct and supervision of school system: lobbying

33 Section 2. A. The general conduct and supervision of the  
34 public school system shall be vested in a state board of education, a  
35 state superintendent of public instruction, county school  
36 superintendents, and such governing boards for the state institutions  
37 as may be provided by law.

38 B. A MEMBER OF A SCHOOL DISTRICT GOVERNING BOARD MAY NOT  
39 ENGAGE IN PAID LOBBYING FOR ANY PERSON OR ENTITY EXCEPT FOR THAT  
40 SCHOOL DISTRICT GOVERNING BOARD.

1 4. Article XII, section , Constitution of Arizona, is proposed to be  
2 amended as follows if approved by the voters and on proclamation of the  
3 Governor:

4 3. County officers; election; term of office; supervisors;  
5 lobbying

6 Section 3. A. There are hereby created in and for each  
7 organized county of the state the following officers who shall be  
8 elected by the qualified electors thereof: a sheriff, a county  
9 attorney, a recorder, a treasurer, an assessor, a superintendent of  
10 schools and at least three supervisors, each of whom shall be elected  
11 and hold his office for a term of four (4) years beginning on the  
12 first of January next after his election, which number of supervisors  
13 is subject to increase by law. The supervisors shall be nominated  
14 and elected from districts as provided by law.

15 B. The candidates for these offices elected in the general  
16 election of November 3, 1964 shall take office on the first day of  
17 January, 1965 and shall serve until the first day of January, 1969.

18 C. A MEMBER OF THE COUNTY BOARD OF SUPERVISORS MAY NOT ENGAGE  
19 IN PAID LOBBYING FOR ANY PERSON OR ENTITY EXCEPT FOR THAT COUNTY  
20 BOARD OF SUPERVISORS.

21 5. Article XIII, Constitution of Arizona, is proposed to be amended  
22 by adding section 8 as follows if approved by the voters and on  
23 proclamation of the Governor:

24 8. City or town council members; mayor; lobbying  
25 prohibited

26 SECTION 8. A MEMBER OF A CITY OR TOWN COUNCIL OR THE  
27 MAYOR OF A CITY OR TOWN MAY NOT ENGAGE IN PAID LOBBYING FOR ANY  
28 PERSON OR ENTITY EXCEPT FOR THAT CITY OR TOWN.

29 6. The Secretary of State shall submit this proposition to the  
30 voters at the next general election as provided by article IV, part 1,  
31 section 1, Constitution of Arizona."
